1. 2.	Compliance of the points no. 1 to 6 may be submitted within 03 months on the SARAS Portal, failing which due action will be taken.

1	The total number of section of the school shall be restricted to 28 , of which not more than 1/3rd sections may be used for senior secondary classes and further increase shall be subject to specific approval of the Board on the basis of the request of the school as per affiliation by laws.
2	The CWSN toilets seen in the video are not as per norms, in terms of infrastructural supports .In the absence of signage, whether CWSN toilets are on every floor is still not clear(stand alone video of identical cubicles are seen).The school shall make provision for separate toilets for CWSN, boys and girls on every floor with clear signage, mentioning the floor and as per norms of RPwD Act and guidelines issued by the Board and submit compliance within 3 months on SARAS The school must ensure provision for CWSN such as ramp at the entrance, ramp / lift to access upper floors

3	The school is required to undergo training program for teachers from CoE Chandigarh within three months and submit compliance within 3 months in SARAS portal..


